Washington, D. C .-- For the first time, a Presidential inauguration was moved forward from the traditional March 4 to January 20, in accordance with the new law. In beginning his second term on the latter date, President Roosevelt will be the first elected President not to serve a full four years, since his new term will end January 20, 1941, and he will lose his salary for six weeks, originally having taken office on March 4.




### Hearne Homes **Being Improved**
