CONDITIONS OF SERVICE (and a part of this contract)

- No fee refunded in whole or in part.
- A guarantee of actual mating only is made (mating observed) and not of pregnancy or of kittens living or dead.
- If doe fails to be pregnant, the owner must give notice to me not later than twenty-five days after last date of mating. A return service will be given to the same stud without charge during the next thirty days. Unless such notice is given, the right to a return service is forfeited. The owner of the doe to be responsible for her transport both ways, as well as for any other transportation expenses incurred.
- If my stud dies, is sold, or otherwise is not available, I have the right to mate the doe with one of my other studs, my choice, unless both parties agree mutually on another choice.
- If doe changes ownership, right of full return service is at my option.
- In order to assure myself of the pregnancy condition of the doe, the right to see and examine her is granted.
- If a kitten is to be received instead of or in addition to cash fee, I will make my choice of litter at age of 6 weeks. One kitten constitutes a litter and if there is only one kitten, regardless of sex, this kitten shall constitute my choice of litter.
- If all kittens are born dead, or none survive to age of 6 weeks, I have postponed right to choice of kitten through mating to my stud, but a repeat service is at my option. NO cash compensation is due me. If same condition occurs at second breeding, obligations of both parties are terminated. These rights (choice of kitten) are not affected by change of ownership of doe.
- Important: Any ADDITIONAL or SPECIAL agreements, conditions, or provisions are noted on the other side of this certificate, over my written signature.
